TRANSPARENT BILLING

The mediation fee is calculated based on the hourly billing rate as detailed below:

- 2 Parties: \$225 per party, per hour
- 3 Parties: \$175 per party, per hour
- 4 or More Parties: \$150 per party, per hour

A “party” is defined as all individuals represented by the same attorney. The hourly fee includes time spent in session, as well as preparation, review of submissions, communications with counsel, and post-mediation follow-up. Fees are divided equally among the parties unless otherwise agreed in advance.

MINIMUM FEE

- Half-Day Mediation: 4-hour minimum
- Full-Day Mediation: 7-hour minimum

The applicable minimum is billed for any mediation reserved for that time period.

CANCELLATION POLICY

If a mediation is cancelled or rescheduled within five (5) business days of the scheduled session, the applicable minimum fee will be charged and divided equally among the parties, unless all parties agree otherwise. All cancellations must be submitted in writing or by email, with the consent of all parties and counsel, if any.

BILLING & PAYMENT

Invoices are issued promptly following the mediation. Payment is due upon receipt unless otherwise agreed in advance. Payments may be made by check or electronic transfer as indicated on the invoice.



